This British Standard is the UK implementation of EN 60335-2-28:2003+A11:2018. It is derived from IEC 60335-2-28:2002, incorporating amendment 1:2008. It supersedes BS EN 60335-2-28:2003+A1:2008, which will be withdrawn on 28 September 2021.

The start and finish of text introduced or altered by amendment is indicated in the text by tags. Tags indicating changes to text carry the number of the CENELEC or IEC amendment. For example, text altered by CENELEC amendment A11 is indicated by $\overline{A11}$ $\overleftarrow{A11}$; text altered by IEC amendment A1 is indicated by $\overline{A1}$ $\overleftarrow{A1}$.

The CENELEC common modifications have been implemented at the appropriate places in the text. The start and finish of each common modification is indicated in the text by tags \overline{C} \overleftarrow{C} .
