This British Standard is the UK implementation of EN 60335-2-13:2010+A1:2019. It is derived from IEC 60335-2-13:2009, incorporating amendment 1:2016. It supersedes BS EN 60335-2-13:2010+A11:2012, which will be withdrawn on 2 August 2022.

Where a common modification has been introduced by amendment, the tags carry the number of the amendment. For example, the common modifications introduced by CENELEC amendment A11 are indicated by $\overline{C11}$ $\overleftarrow{C11}$.

The start and finish of text introduced or altered by amendment is indicated in the text by tags. Tags indicating changes to IEC text carry the number of the IEC amendment. For example, text altered by IEC amendment 1 is indicated by $\overline{A1}$ $\overleftarrow{A1}$.

The UK participation in its preparation was entrusted to Technical Committee CPL/61/7, Safety of electrical appliances - Heated appliance group.
