This British Standard is the UK implementation of <u>EN 16354:2018</u>. It supersedes <u>PD CEN/TS 16354:2013</u>, which is withdrawn.

The UK participation in its preparation was entrusted to Technical Committee PRI/60, Resilient and Laminate Floor Coverings.

A list of organizations represented on this committee can be obtained on request to its secretary.

BSI, as a member of CEN, is obliged to publish <u>EN 16354:2018</u> as a British Standard. However, attention is drawn to the fact that during the development of this European Standard, the UK committee voted against its approval.

The UK committee submitted a negative vote as EN 16354:2018 requires a compressive strength (CS) threshold of \geq 10 kPa. The UK committee is of the opinion that underlays with a compressive strength of \geq 5 kPa can perform under certain end-use scenarios. The committee therefore recommends that, in addition to testing, the underlay manufacturer provide guidance on the use of its product for the required end use.
