### ***CSA Preface***

This is the third edition of CSA C22.2 No. 60335-2-50, *Household and similar electrical appliances — Safety — Part 2-50: Particular requirements for commercial electric bains-marie*, which is an adoption, with Canadian deviations, of the identically titled IEC (International Electrotechnical Commission) Standard 60335-2-50 (edition 4:2002 consolidated with Amendment 1:2007 and Amendment 2:2017). It supersedes the previous edition published in 2001 as CAN/CSA-E60335-2-50 (adopted IEC 60335-2-50:2000). It also replaces the requirements for commercial electric bains-marie found in CSA C22.2 No. 109-17, *Commercial cooking appliances*. It is one in a series of Standards issued by CSA Group under Part II of the *Canadian Electrical Code*. At the time of publication, IEC 60335-2-50:2002+A1:2007+A2:2017 is available from IEC in English only. CSA Group will publish the French version when it becomes available from IEC.

For brevity, this Standard will be referred to as “CSA C22.2 No. 60335-2-50” throughout.

This Standard is intended to be used in conjunction with CAN/CSA-C22.2 No. 60335-1:16, *Household and similar electrical appliances — Safety — Part 1: General requirements* (adopted IEC 60335-1:2010+A1:2013, with Canadian deviations).

This Standard is considered suitable for use for conformity assessment within the stated scope of the Standard.

This Standard was reviewed for Canadian adoption by the CSA Technical Committee on Consumer and Commercial Products, under the jurisdiction of the CSA Strategic Steering Committee on Requirements for Electrical Safety, and has been formally approved by the Technical Committee.

This Standard has been developed in compliance with Standards Council of Canada requirements for National Standards of Canada. It has been published as a National Standard of Canada by CSA Group.

**Interpretations:** The Strategic Steering Committee on Requirements for Electrical Safety has provided the following direction for the interpretation of standards under its jurisdiction: “The literal text shall be used in judging compliance of products with the safety requirements of this Standard. When the literal text cannot be applied to the product, such as for new materials or construction, and when a relevant

CSA committee interpretation has not already been published, CSA Group's procedures for interpretation shall be followed to determine the intended safety principle."

This Standard applies to the above-noted products that are intended to be installed or used in accordance with CSA C22.1, *Canadian Electrical Code, Part I*.

This Standard does not apply to electrical equipment on coal- or gas-heated cooking equipment.

General requirements applicable to these products are provided in CAN/CSA-C22.2 No. 0.

## 5 General conditions for the tests

### 5.102A

Appliances provided with socket outlets shall be tested with the socket outlet loaded with a 1500 W resistive load if this load would adversely affect the result of the test. This includes the tests of Clauses 10, 11, and 19.

## 6 Classification

### 6.1

*[Replace the first paragraph of the “Replacement” in the Part 2 with the following]*

Appliances shall be **class I** or **class II** with respect to protection against electric shock.

## 7 Marking and instructions

### 7.1

*[Add the following]*

The input to cord-connected appliances for use on nominal 120 V branch circuits protected by overcurrent devices rated or set at not more than 15 A shall not exceed 1500 W at 120 V.
