This standard has been prepared by Technical Committee CEN/TC 52 "Safety of toys" (Secretariat: DS, Denmark) under a mandate of the European Commission and the European Free Trade Association.

The responsible German body involved in its preparation was the *Normenausschuss Gebrauchstauglichkeit* und Dienstleistungen (Performance Capability and Services Standards Committee), Technical Committee NA 039-02-01-03 UA *Organisch-chemische Verbindungen in Spielzeug*.

This standard is the consolidated version of EN 71-9:2005. It incorporates Amendment EN 71-9:2005/A1:2007 and Corrigendum EN 71-9:2005/AC:2007. The corrections contained in Corrigendum AC:2007 concern the German version only.

Amendments

This standard differs from DIN EN 71-9:2005-05 and DIN EN 71-9 Corrigendum 1:2007-06 as follows:

- a) Amendment A1:2007 including the following has been incorporated:
 - 1) At various places in the text the term "document" has been replaced by "standard".
 - 2) Throughout the text, references to prEN 71-10 and prEN 71-11 have been replaced by references to EN 71-10 and EN 71-11.
 - 3) In the introduction the fourth paragraph has been replaced.
 - 4) In Table 1, line 10, the reference to footnote a has been deleted.
 - 5) Subclause A.1 has been replaced.
- b) Corrigendum 1:2007-06 concerns the German version only and includes the following:
 - 1) In Table 2 E, column "Limit", lines 3 to 7, "5 mg/l (total)" has been changed to "0,5 mg/l (total)".
 - 2) In Table 2 H, column "Limit", lines 3 and 4, "10 mg/l" has been changed to "10 mg/kg".
