This standard includes safety requirements.

This document (EN 1888-2:2018) has been prepared by Technical Committee CEN/TC 252 “Child use and care articles” (Secretariat: AFNOR, France).

The responsible German body involved in its preparation was *DIN-Normenausschuss Sicherheitstechnische Grundsätze* (DIN Standards Committee Safety Design Principles), Working Committee NA 095-05-03 AA “Child use and care articles — Seating and body care, protection, lying down and transportation”.

## **Amendments**

This standard differs from DIN EN 1888:2012-06 as follows:

- a) DIN EN 1888:2012-06 has been subdivided into two separate parts. This part includes requirements and test methods for pushchairs for children of 15 kg to 22 kg. General requirements and test methods for prams and pushchairs have been specified in DIN EN 1888-1:2019-05;
- b) the standard has been brought in line with the current rules of presentation.
