Amendments

This standard differs from DIN EN 71-13:2021-06 as follows:

- a) Table 1 and Table 2 have been revised to reflect the changes in the listing of allergenic fragrances in Directive 2009/48/EC based on Commission Directive (EU) 2020/2088 and Commission Directive (EU) 2020/2089;
- b) requirements for cosmetic kits (4.2.1 “General”) and for gustative games (4.3.1 “General”) have been slightly revised;
- c) requirements in 6.1 “General markings and warnings” have been revised, and, in particular, Table 3 containing allergenic fragrances which shall be listed on the toy, on an affixed label, on the packaging or in an accompanying leaflet has been added;
- d) explanations on allergenic fragrances in A.1 have been revised to reflect the changes in the listing of allergenic fragrances in Directive 2009/48/EC based on Commission Directive (EU) 2020/2088 and Commission Directive (EU) 2020/2089;
- e) notes in Table ZA.1 have been added;
- f) the Bibliography has been updated.
