## **National foreword**

This document (CEN/TR 17376:2019) has been prepared by Technical Committee CEN/TC 248 “Textiles and textile products” (Secretariat: BSI, United Kingdom).

The responsible German body involved in its preparation was *DIN-Normenausschuss Textil und Textilmaschinen* (DIN Standards Committee Textiles and Textile Machinery), Working Committee NA 106-01-02 AA “Textiles — Designation, requirements and test methods; Mirror Committee to CEN/TC 248/WG 10, WG 20 and ISO/TC 133”.

This document replaces DIN CEN/TR 16446 (DIN SPEC 61446):2013, *Textiles — Safety of children’s clothing — Guidance on the use of EN 14682:2007, Cords and drawstrings on children’s clothing — Specifications*.

The European reference document CEN/TR 16446:2012 was withdrawn without replacement in 2016 because the European reference document EN 14682:2007, *Safety of children’s clothing — Cords and drawstrings on children’s clothing — Specifications* had been revised and republished in 2014. In 2018, the European Working Group CEN/TC 248/WG 20 “Safety of children’s clothing” decided to not yet forgo the provision of a guide on the application of EN 14682:2014. This has resulted in CEN/TR 17376:2019 being prepared and published.
