Compliance with the requirements specified therein may, subsequent to verification of compliance by an accredited test house designated by the *Bundesminister für Arbeit und Sozialordnung* (German Federal Minister for Labour and Social Affairs), be indicated by marking the beds and mattresses with the symbol *GS = Geprüfte Sicherheit* (Safety tested) mark.
