Amendments

This standard differs from DIN EN 1335-1:2002-08 and DIN EN 1335-1 Corrigendum 1:2002-11 as follows:

- a) a new test method of measurements based on ISO 24496 has been included;
- b) a new chair type (Type Ax) has been introduced to cover a wider range of the population than Type A chair;
- c) dimensional requirements have been moved from the annex to the main part of the standard;
- d) a new Annex A which gives a rationale for chair dimensions has been introduced;
- e) a new Annex B which gives an example of "how to use" Table 2 has been introduced;
- f) a new Annex C which gives dimensions of neck rests and headrests has been introduced;
- g) a new Annex D which includes measurement uncertainty has been introduced;
- h) A-deviations have been deleted;
- i) the standard has been editorially revised.
