This document (EN 16579:2018+AC:2019) has been prepared by Technical Committee CEN/TC 136 "Sports, playground and other recreational facilities and equipment", Working Group WG 22 "Gymnastic and playing field equipment" (Secretariat: DIN, Germany).

The responsible German body involved in its preparation was *DIN-Normenausschuss Sport- und Freizeitgerät* (DIN Standards Committee Sports Equipment), Working Committee NA 112-01-02 AA "Gymnastic equipment, mats and playing field equipment".
