# National foreword

This document (EN 581-2:2015 + AC:2016) has been prepared by Technical Committee CEN/TC 207 "Furniture" (Secretariat: UNI, Italy).

The responsible German body involved in its preparation was *DIN-Normenausschuss Holzwirtschaft und Möbel* (DIN Standards Committee Timber and Furniture), Working Committee NA 042-05-04 AA *Anforderungen an Außenmöbel, SpA CEN/TC 207/WG 4*.

This standard includes safety requirements within the meaning of the *Produktsicherheitsgesetz* (ProdSG) (German Product Safety Act).

Where this standard has been identified by the *Ausschuss für Produktsicherheit* (German Committee for Product Safety) and reference to it has been published in the *Gemeinsames Ministerialblatt* (German Joint Ministerial Gazette) by the *Bundesanstalt für Arbeitsschutz und Arbeitsmedizin (BAuA)* (German Federal Institute for Occupational Safety and Health), it is to be presumed that seating which complies with this standard fulfil the relevant health and safety requirements.

This standard includes Corrigendum A1, approved by CEN on 13 July 2016.

The start and finish of text introduced or altered by amendment is indicated in the text by tags (AC).

#### **Amendments**

This standard differs from DIN EN 581-2:2009-08 as follows:

- a) new requirements for tests have been included, and loungers are no longer in an annex but in the standard, which is a simplification of the standard (requirements and clauses have been harmonized with Clause 7 of the standard);
- b) a simplification of Clause 5 "test equipment" has been made;
- c) a modification of reference (EN 1728:2012) has been made.

Compared with DIN EN 581-2:2009-08, the following corrections have been made:

- a) In Table 1, the following has been added to the second test: test parameters "Cycles", Camping "10", Domestic "10", Contract "10", and test parameters "Additional cycle 30 min ± 10 s", Camping "1", Domestic "1", Contract "1".
- b) In Table 1, the following has been added to the sixth test: test parameters "Cycles", Camping "10", Domestic "10", Contract "10".
- c) In Table 2, the following has been added to the fifth test: test parameters "Cycles", Camping "10", Domestic "10", Contract "10".
- d) In Table A.1, the following has been added: designation of force "F<sub>B.4</sub>", Force value "20".
