National foreword

This document (EN 581-1:2017) has been prepared by Technical Committee CEN/TC 207 "Furniture", (Secretariat: UNI, Italy).

The responsible German body involved in its preparation was *DIN-Normenausschuss Holzwirtschaft und Möbel* (DIN Standards Committee Timber and Furniture), Working Committee NA 042-05-04 AA "Requirements of outdoor furniture, Mirror Committee to CEN/TC 207/WG 4".

In Clause 5, this standard includes safety requirements within the meaning of the *Produktsicherheitsgesetz* (ProdSG) (German Product Safety Act).

Where this standard has been identified by the *Ausschuss für Produktsicherheit* (German Committee for Product Safety) and reference to it has been published in the *Gemeinsames Ministerialblatt* (German Joint Ministerial Gazette) by the *Bundesanstalt für Arbeitsschutz und Arbeitsmedizin (BAuA)* (German Federal Institute for Occupational Safety and Health), it is to be presumed that outdoor furniture and tables which comply with this standard fulfil the relevant health and safety requirements.

Amendments

This standard differs from DIN EN 581-1:2006-05 as follows:

- a) a clarification of the definitions (camping, domestic and contract use) has been taken out of Annex B and put in Clause 3 (which replaces the former Annex B);
- test probes and test methods have been replaced; requirements for edges and corners have been modified to take into account accessible parts during use (accessible parts of seating and tables have been defined);
- c) tubular components have been defined; requirements for gaps and holes have been removed;
- d) Annex B (informative) has been included as a rationale to explain the risks covered with the requirements in Clause 5.
