This document (EN 747-2:2012+A1:2015) has been prepared by Technical Committee CEN/TC 207 “Furniture”, (Secretariat: UNI, Italy).

The responsible German body involved in its preparation was the *DIN-Normenausschuss Holzwirtschaft und Möbel* (DIN Standards Committee Timber and Furniture), Working Committee NA 042-05-13 AA *Anforderungen an Kindermöbel*, SpA CEN/TC 207/WG 2, CEN/PC 364.

This standard includes safety requirements within the meaning of the *Produktsicherheitsgesetz* (ProdSG) (German Product Safety Act).

Where this standard has been identified by the *Ausschuss für Produktsicherheit* (German Committee for Product Safety) and reference to it has been published in the *Gemeinsames Ministerialblatt* (German Joint Ministerial Gazette) by the *Bundesanstalt für Arbeitsschutz und Arbeitsmedizin (BAuA)* (German Federal Institute for Occupational Safety and Health), it is to be presumed that bunk beds and high beds which comply with this standard fulfil the relevant health and safety requirements.

## **Amendments**

- b) Subclause 5.3 “Measurements” has been extended;
- c) the standard has been editorially revised.
