This standard includes safety requirements within the meaning of the *Produktsicherheitsgesetz* (ProdSG) (German Product Safety Act).

This document (EN 1271:2014) has been prepared by Technical Committee CEN/TC 136 "Sports, playground and other recreational facilities and equipment", Working Committee WG 22 "Gymnastic and playing field equipment" (Secretariat: DIN, Germany).

The responsible German body involved in its preparation was the *DIN-Normenausschuss Sport- und Freizeit-gerät* (DIN Standards Committee Sports Equipment), Working Committee NA 112-01-02 AA *Turngeräte, Matten und Spielfeldgeräte.*

Where this standard has been identified by the *Ausschuss für Produktsicherheit* (German Committee for Product Safety) and reference to it has been published in the *Gemeinsames Ministerialblatt* (German Joint Ministerial Gazette) by the *Bundesanstalt für Arbeitsschutz und Arbeitsmedizin (BAuA)* (German Federal Institute for Occupational Safety and Health), it is to be presumed that volleyball equipment which complies with this standard fulfils the relevant health and safety requirements.

Amendments

This standard differs from DIN EN 1271:2006-01 as follows:

- a) the scope has been modified regarding the umpire stand;
- b) sitting volleyball has been considered;
- c) dimensions have been modified;
- d) material requirements have been modified;
- e) net breaking strength requirements have been modified;
- f) breaking forces of ropes/net lines have been modified;
- g) breaking forces for the top net line have been modified;
- h) breaking forces for the net tape have been deleted;
- i) the antennae requirement regarding colouring has been modified;
- j) safety requirements for the posts, tensioning devices, rope and rope attachments have been modified;
- k) safety requirements for post pads have been supplemented;
- the test method and test forces for the posts, tensioning devices, rope and rope attachments have been modified (overall test);
- m) the instruction for use has been modified;
- n) requirements for marking have been supplemented.
