This standard includes in Clauses 5 and 7 and in Annex A safety requirements within the meaning of the *Produktsicherheitsgesetz* (ProdSG) (German Product Safety Act).

Where this standard has been identified by the *Ausschuss für Produktsicherheit* (German Committee for Product Safety) and reference to it has been published in the *Gemeinsames Ministerialblatt* (German Joint Ministerial Gazette) by the *Bundesanstalt für Arbeitsschutz und Arbeitsmedizin (BAuA)* (German Federal Institute for Occupational Safety and Health), it is to be presumed that furniture which complies with this standard fulfils the relevant health and safety requirements.

The German GS mark (GS stands for *Geprüfte Sicherheit*, meaning safety tested) may then be applied under the provisions laid down in Section 5 of the Product Safety Act.

This document (EN 16121:2013+A1:2017) has been prepared by Technical Committee CEN/TC 207 "Furniture" (Secretariat: UNI, Italy).

The responsible German body involved in its preparation was *DIN-Normenausschuss Holzwirtschaft und Möbel* (DIN Standards Committee Timber and Furniture), Working Committee NA 042-05-02 AA "Storage furniture, Mirror Committee to CEN/TC 207/WG 1/WG 5/WG 9 and ISO/TC 136/WG 3".
