This document (EN 13089:2011+A1:2015) has been prepared by Technical Committee CEN/TC 136 "Sports, playground and other recreational facilities and equipment", Working Group WG 5 "Mountaineering and climbing equipment" (Secretariat: DIN, Germany).

The responsible German body involved in its preparation was the *DIN-Normenausschuss Sport- und Freizeitgerät* (DIN Standards Committee Sports Equipment), Working Committee NA 112-04-05 AA *Bergsteigerausrüstung.*

Where this standard has been identified by the *Ausschuss für Produktsicherheit* (German Committee for Product Safety) and reference to it has been published in the *Gemeinsames Ministerialblatt* (German Joint Ministerial Gazette) by the *Bundesanstalt für Arbeitsschutz und Arbeitsmedizin (BAuA)* (German Federal Institute for Occupational Safety and Health), it is to be presumed that ice-tools which comply with this standard fulfil the relevant health and safety requirements.

Amendments

This standard differs from DIN EN 13089:2011-05 as follows:

- a) Clause 6 "Marking" has been rendered more precise for the different categories of picks;
- b) Clause 7 "Information to be supplied by the manufacturer" has been extended to include a new item c) concerning the meaning of markings on the product.
