This standard takes effect on 01 October 2008.

National foreword

This standard includes in clause 4 safety requirements within the meaning of the *Geräte- und Produktsicherheitsgesetz* (German Equipment and Product Safety Law).

This standard has been prepared by Technical Committee CEN/TC 136 “Sports, playground and other recreational facilities and equipment” (Secretariat: DIN, Germany).

The responsible German body involved in its preparation was the *Normenausschuss Sport- und Freizeitgerät* (Sports Equipment Standards Committee), Technical Committee NA 112-07-01 AA *Spielplatzgeräte*.

Playground equipment as specified in this standard falls within the scope of the *Geräte- und Produktsicherheitsgesetz*. Once compliance with the safety requirements specified therein has been verified by an accredited test house designated by the German Federal Ministry of Labour and Social Affairs, the playground equipment may be marked with the symbol GS (= *geprüfte Sicherheit*, safety tested).

Compared with DIN EN 1176-10:2008-08, the following corrections have been made to the German version only and therefore do not affect the English text:

- a) In Figure 1, item 7 of the key, 15° min. has been added.
- b) In subclause 4.4.1.6, the angle of declination has been corrected to read “mindestens 15°” (at least 15°).
