Amendments

This standard differs from DIN EN 71-13:2014-07 as follows:

- a) in 4.1, the requirements for olfactory board games, in particular regarding substances and mixtures (4.1.2), have been slightly revised;
- b) in 4.2, the requirements for cosmetic kits, in particular regarding substances and mixtures (4.2.2, the heading has been changed to "Fragrances"), have been revised;
- c) in 4.3, the requirements for gustative games, in particular regarding substances and mixtures (4.3.2), have been slightly revised;
- d) in Clause 5, the requirements for the equipment, in particular regarding containers and glassware (5.2), have been slightly revised, and the requirements for closures of child-resistant containers have been revised to permit only closures according to EN ISO 8317:2015;
- e) in Clause 6, the requirements for general markings and warnings (6.1) have been revised;
- f) some explanations in Annex A have been revised, and additional explanations on markings and warnings have been added;
- g) the test method for the closures of containers (Annex C) has been deleted;
- h) the Bibliography has been updated, in particular with regard to changes in legislation.
