## Foreword

This translation has been made based on the original Japanese Industrial Standard revised by the Minister of Economy, Trade and Industry through deliberations at the Japanese Industrial Standards Committee as the result of proposal for revision of Japanese Industrial Standard submitted by Japan Office & Institutional Furniture Association (JOIFA)/ Japanese Standards Association (JSA), draft being attached, based on the provision of Article 12 Clause 1 of the Industrial Standardization Law applicable to the case of revision by the provision of Article 14.

Standards of JIS S 1039 and JIS S 1040 are unified at the time of revision because of both standards having common elements such as similar principal construction components such as column, shelf board, shelf board supporting equipment and so on, the uses of storage and archiving goods on the shelf board, and so on.

Consequently JIS S 1040:1994 is withdrawn and JIS S 1039:1989 is revised and replaced with this Standard.

Attention is drawn to the possibility that some parts of this Standard may conflict with a patent right, application for a patent after opening to the public, utility model right or application for registration of utility model after opening to the public which have technical properties. The relevant Minister and the Japanese Industrial Standards Committee are not responsible for identifying the patent right, application for a patent after opening to the public, utility model right or application for registration of utility model after opening to the public which have the said technical properties.
